By signing below, I acknowledge that I have read, understand, and agree to abide by all Rules and Guidelines stated in this Vendor Agreement for the 2026 Dallas Kosher Chili Cookoff (“Event”). I further agree not to hold **Congregation Tiferet Israel**, its officers, employees, agents, volunteers, or affiliates liable for any personal injury, property damage, theft, loss, or other harm arising from or related to my participation in the Event, including but not limited to set-up, operation, sales, or dismantling.

Kashrut Requirements (Food Vendors Only)

All food items intended for sale or sampling **must adhere to strict kosher standards**, must be **non-dairy**, and must be **reviewed and approved** *in advance* by either:

- **The Dallas Vaad HaKashrus**, or
- **Rabbi Levi Dubrawsky**, Head Rabbi of Congregation Tiferet Israel.

The Dallas Kosher Chili Cookoff reserves the right to deny the sale or distribution of any food item that does not meet Dallas Vaad standards or the official kashrut requirements of the Event. Vendors must provide any documentation requested to verify compliance. Failure to comply may result in removal from the Event without refund.

Vendor Responsibilities

- Vendors are responsible for their own signage, display materials, table coverings, and all equipment.
- Vendors must remain for the full duration of the Event (11:00 AM–4:00 PM). **Tear-down may not begin before 4:00 PM.**
- The venue will be available for set-up at:
 - 8:45 PM – Saturday, March 14, 2026** (after Shabbat)
 - 8:30 AM – Sunday, March 15, 2026**

Due to religious observance, no Saturday setup may occur before 8:45 PM.

- **Sunday Setup Window:** Vendor setup on Sunday, March 15, 2026, is permitted only between **8:30 AM and 10:00 AM**. Booth setup must be completed by **10:00 AM**. Vendors arriving after 10:00 AM may not be allowed to set up and risk forfeiting their space without refund.
- Vendors are responsible for cleaning their area fully at the conclusion of the Event. No items or trash may be left behind.

Fees, Tables & Space

- Each vendor space includes:
One (1) 6' x 30" table and two (2) chairs
- Vendors may bring additional display elements at their own expense, provided they do not obstruct walkways or violate fire/safety regulations.

- Items deemed inappropriate, unsafe, or not in keeping with the family-friendly nature of the Event may be removed at the discretion of Event organizers.
- No refunds will be issued for vendor withdrawal, non-compliance, or removal due to violation of Event rules.
